

## FREE DEPOSIT BONUS: TERMS AND CONDITIONS

### A. Introduction

1. The **“free no deposit bonus”** may be offered by Trading Point of Financial Instruments Ltd. (**“Trading Point”**) from time to time to clients who open live active trading accounts with Trading Point, in cases where such clients are referred to Trading Point via specific websites and/or social network sites in the context of certain specific promotions, contests and/or surveys that trading Point may be running from time to time on such specific websites and/or social network sites. **Trading Point of Financial Instruments Ltd.** is a Cyprus Investment Firm authorized and regulated under MiFID by the Cyprus Securities and Exchange Commission (CySEC) - License Number 120/10 - and is registered with the Financial Services Authority in the United Kingdom (FSA) under Number 538324.
2. The **“free no deposit bonus”** is available only to clients who are referred to Trading Point via such specific websites and/or social network sites, in the event that the **“free no deposit bonus”** is specifically mentioned as part of a specific promotion, contest and/or survey that Trading Point may be running from time to time on such specific websites and/or social network sites (**“Eligible Clients”**). Persons who are not referred to Trading Point via such specific websites and/or social networking sites in the context of a specific promotion, contest and/or survey, which Trading Point may be running on such specific websites and/or social network sites and which specifically mentions the **“free no deposit bonus”** as part of the specific promotion, contest and/or survey in question, are not entitled to the **“free no deposit bonus”**.
3. Trading Point reserves the right, at its sole discretion, to decline registration of any participant in the **“free no deposit bonus”** scheme without having to explain the reasons and further reserves the right to disqualify any participant in the **“free no deposit bonus”** scheme who tampers or attempts to tamper with the operation of the **“free no deposit bonus”** scheme, these Terms & Conditions and/or any of the Business Terms and Policies set forth on Trading Point’s Website at the following URL: <http://www.trading-point.com/legal-documents>.
4. The **“free no deposit bonus”** scheme is available for a limited period of time only, as indicated in the rules of engagement of the specific promotion, contest and/or survey of which the **“free no deposit bonus”** scheme is mentioned to be a part.
5. Trading Point reserves the right to alter, amend or terminate the **“free no deposit bonus”** scheme, or any aspect of it, at any time and without prior notice. Trading Point post any such changes on the Trading Point Website at the following URL: <http://www.trading-point.com/download/docs/tp-no-bonus.pdf>. It is recommended that participants in the **“free no deposit bonus”** scheme consult these Terms & Conditions on the Trading Point Website regularly. Please note that taking part in the **“free no deposit bonus”** scheme constitutes acceptance and agreement to abide by any such alterations, amendments and/or changes.
6. Taking part in the **“free no deposit bonus”** scheme constitutes acceptance of these Terms & Conditions and of the Business Terms and Policies set forth on Trading Point’s Website at the following URL: <http://www.trading-point.com/legal-documents>.

## B. Conditions of Eligibility

7. In order to qualify for the **“free no deposit bonus”**, Eligible Clients must provide Trading Point with true, accurate, current and complete information, including their full name, identical to that specified in their ID documentation, as well as an active contact e-mail, and must upload all necessary, clear and legal documents in the member’s area. Eligible Clients must agree not to impersonate any person or entity, misrepresent any affiliation with another person, entity or association, use false headers or otherwise conceal their identity for any purpose. Trading Point will treat with care all such information that is entrusted to it, in accordance with the disclosures provided during the registration process and in Trading Point’s Privacy Policy.
8. During the registration process Eligible Clients will be asked to choose a **‘username’** and **‘password’** that will be used by them every time they access their account with Trading Point and use Trading Point’s services. For their protection and that of other users of Trading Point’s services, Eligible Clients should not share their registration information (including their **‘username’** and **‘password’**) with any other person or business entity for any purpose including, but not limited to, facilitating access and unauthorized use of Trading Point’s services. Eligible clients are solely responsible for all acts or omissions that occur within their account with Trading Point and/or Trading Point’s Website(s) through the use of their registration information. If an Eligible Client believes that someone has used or is using his or her registration information, **‘username’** or **‘password’** to access any of Trading Point’s services without his or her prior authorization, he or she should notify Trading Point immediately.
9. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the **“free no deposit bonus”** scheme. Without limiting the foregoing, participation in the **“free no deposit bonus”** scheme is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence (“minors”). **If you are a minor, you may not participate in the “free no deposit bonus” scheme.**
10. Participation of **“Intermediaries/Related Parties”** in the **“free no deposit bonus”** scheme is prohibited. If the registration data of a participant in the **“free no deposit bonus”** scheme corresponds with the registration information of another participant in the **“free no deposit bonus”** scheme, Trading Point reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term **“Intermediary(ies)/Related Party(ies)”**, when used in these Terms & Conditions, unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the **“free no deposit bonus”** scheme , including, without limitation:
  - a. family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;
  - b. any person or entity, whom any participant in the **“free no deposit bonus”** scheme, directly or indirectly through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the **“free no deposit bonus”** scheme; for purposes of this definition, the term **“control”** (including, with

correlative meaning, the terms “**controlled by**” and “**under common control with**”), as used with respect to any participant in the “**free no deposit bonus**” scheme, shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.

11. Similarly, persons associated in any manner whatsoever with Trading Point and/or with the specific websites and/or social network sites on which Trading Point may be running from time to time certain specific promotions, contests and/or surveys, in the context of which access to the “**free no deposit bonus**” scheme is offered, are not allowed to participate in the contest.

### C. No Deposit Bonus Terms

12. Please note that it may take up to 72 hours before any “**free no deposit bonus**” is added to the account of an Eligible Client who meets all of the criteria set forth herein.
13. “**Free no deposit bonuses**” applied to the live trading accounts of Eligible Clients in accordance with the rules set forth herein may be used for trading purposes only and cannot be withdrawn.
14. Profits from trading on the live trading accounts of Eligible Clients may, however, be withdrawn anytime, provided that the trading volume in the relevant live trading account reaches at least 50 micro lots, and provided that at least 10 standard round turn trades have been completed. The number of lots traded and of round turn trades realized can be verified by logging in to account under the “**Account History**” tab or by logging in to [my.trading-point.com](http://my.trading-point.com) under the “**Reports**” “**Trading History**” tab.
15. “**Free no deposit bonuses**” applied to the live trading accounts of Eligible Clients in accordance with the rules set forth herein cannot be transferred between live trading accounts with Trading Point.
16. Subject to the provisions set forth above, the minimum amount that can be withdrawn from any account that participates in the “**free no deposit bonus**” scheme cannot be less than 50,- USD and that in order to be able to withdraw from any such accounts all orders (including pending orders) must be closed.
17. Trading Point reserves the right to decline client’s bonus application without explaining the reason and prior notification. Trading Point of Financial Instruments is not liable for any consequences of the bonus cancelation included but not limited to order(s) closure by Stop Out.
18. Expert advisors, scalping, arbitrage and news trading are not allowed in any account that is participating in the “**free no deposit bonus**” scheme. Similarly, the use of proxies is not allowed with respect to any such accounts either. All trading instruments that are available in the trading terminal may be used for trading. All orders that are put at non-market prices will be cancelled.
19. No partner’s commissions are paid for trading in any account that participates in the “**free no deposit bonus**” scheme.

#### **D. Miscellaneous Provisions**

20. In the event that a participant in in the “*free no deposit bonus*” scheme is disqualified for any reason whatsoever, Trading Point reserves the right to close all accounts, cancel all orders and annul all profits of such participant.
21. These Terms & Conditions shall be governed by and construed in accordance with the Laws of the Republic Cyprus. Any dispute or situation not covered by these Terms & Conditions will be resolved by the management of Trading Point in the manner it deems to be the fairest to all concerned. That decision shall be final and/or binding on all participants. No correspondence will be entered into.
22. If any of these Terms & Conditions were to be translated into a language other than English, then the English version of these Rules of Engagement shall prevail where there is an inconsistency.

#### **E. Risk Warning**

23. It is important that Eligible Clients are aware that their risks are not limited to their deposit(s) and that by making a qualifying trade it is possible to lose more than the deposit. In some circumstances, losses may be considerably more than any initial or minimum deposit.
